a. Review of Updated Use Application - PUR-FORM

Mr Duffell informed the authority of PURFORM's participation in the Research Park and Florida Atlantic University since 2021. Ms. Torres thanked PURFORM for their efforts in regenerative medicine and gave an overview of her meeting with PURFORM. She requested additional internship opportunities for FAU students.


Ms. Torres suggested a Google Forms application for potential Research Park tenants, including some more specific questions and answers, offering to create a first draft.
